**NOMINATION ANNOUNCEMENT FOR THE EXECUTIVE COMMITTEE**

As per the Bylaws of the Jain Center of Southern California (JCSC), our Center has two governing bodies: the Executive Committee (EC) and the Board of Directors (BOD).

**The Executive Committee has responsibility for the general day-to-day operations of JCSC.** For instance, the Executive Committee is responsible for organizing and coordinating religious and cultural activities, manage the Derasar and the library, organize and schedule JCYC classes, etc. On the other hand, the Board of Directors is involved with broad policy and setting future goals and direction for the Center. Specifically, it has responsibility for future facility expansions, management of existing assets, and coordinating major repairs and renovations. Four officers of the Executive Committee, namely, the President, the Vice-President, the Secretary, and the Treasurer also serve on the Board of Directors.

The **Executive Committee** consists of 15 members including five Officers: the President, the Vice-President, the Secretary, the Treasurer, and the Public Relations Officer. All members including the five officers have a two-year term. **Eight (8) EC positions are open this year.**

The Nomination Committee is seeking nominations for positions as indicated on the Executive Committee Nomination form, and invites interested and **dedicated life members** to serve on the Executive Committee. Candidates are urged to carefully review the eligibility requirements before completing the Nomination form. **Candidates should also note that they must submit only one Nomination form—either for the Executive Committee or for the Board of Directors.** In case no specific application is received for the position 21-35 age group, or First time EC positions, then any vacant position will be filled from the remainder pool of applicants.

A completed Nomination form should be received **by regular mail, E-mail or Fax** at the address shown below the form. A printed copy of the same form will be available at the temple with Amarishbhai – Pujari Ji. All forms should be received by **September 23, 2013.** The forms should be post-marked latest by **September 20, 2013.** Forms received after **September 23, 2013 midnight** as well as nominations from the floor will not be accepted. A candidate may voluntarily withdraw from consideration by communicating in writing with any member of the Nomination Committee on or before **October 03, 2013.**

The Nomination Committee will present its report to the EC at the EC meeting on **October 09, 2013.** The EC will follow appropriate due process and procedures in considering the nominees. If an election becomes necessary, the election committee appointed by the EC will conduct it.

**ELIGIBILITY REQUIREMENTS**

1. Executive Committee (EC) members must be life members and residents of the State of California. A candidate for the EC must also be a life member for one full year preceding the year of nomination.
2. A candidate for any one of the five officer positions must be a life member for at least five years preceding the year of nomination and must have served on the EC (formerly called the Board) for at least one calendar year.
3. One seat on the EC is reserved for a candidate between the ages of 21 and 35 years.
4. One seat on the EC is reserved for a Life member who has never served on the EC.
5. **Candidates must submit only one nomination form—either for the Executive Committee or for the Board of Directors.**
6. **Completed nomination forms must be received at the address shown below via mail, email or fax on or before September 23, 2013. Alternately, you may submit it via JCSC website by September 23, 2013.**
